The Hunt Test Secretary must receive the veterinarian's statement within 10 working days after the event in order to receive a full refund.

COURSES, BIRDS, CONDITIONS AND ATTIRE

All tests to be run on a single course with a birdfield. These tests will be judged off ATVs on the course. Judges will be on foot in the birdfield.

Native and liberated quail or other game birds.

Bitches in season shall not be eligible for entry and shall not be allowed on the grounds.

All handlers, judges and workers <u>must</u> be attired in an article of blaze orange while on the event grounds.

AKC approved tracking collars will be allowed.
