SCRATCH POLICY

Full refund will be made prior to the drawings. After the drawings are held, only bitches in season, injury, illness, or death with a veterinarian's statement (Chapter 1, Sec 5), shall receive a full refund. The Hunt Test Secretary must receive the veterinarian's statement within 10 working days after the event in order to receive a full refund.

COURSES, BIRDS, CONDITIONS AND ATTIRE

All tests to be run on a single course with a birdfield.

Native and liberated quail or other game birds.

Bitches in season shall not be eligible for entry and shall not be allowed on the grounds.

All handlers, judges and workers must be attired in an article of blaze orange while on the event grounds.

AKC approved tracking collars will be allowed.
