## **SCRATCH POLICY**

Full refund will be made prior to the drawings. After the drawings are held, only bitches in season, injury, illness, or death with a veterinarian's statement (Chapter 1, Sec 5), shall receive a full refund. The Hunt Test Secretary must receive the veterinarian's statement within 10 working days after the event in order to receive a full refund.

## **COURSES, BIRDS, CONDITIONS AND ATTIRE**

All tests to be run on a single course with a birdfield. These tests will be judged off ATVs on the course. Judges will be on foot in the birdfield. Native and liberated quail or other game birds.

**Bitches in season shall not be eligible for entry and shall not be allowed on the grounds.**

All handlers, judges and workers **must** be attired in an article of blaze orange while on the event grounds.

AKC approved tracking collars will be allowed.
